V. Rebate Terms and Conditions

- Air sealing must be installed by a participating contractor in a residence that receives New Mexico Gas Company residential
 gas service, as evidenced by the New Mexico Gas Company customer account number.
- 2. Customer's home MUST have a natural gas fueled heat source as its primary source of heating (primary heat sources using propane, solar or electric are ineligible for rebate payment).
- 3. To qualify for duct sealing incentives, participating contractor must perform pre and post door blower test leakage. The results of the blower test must reduce overall leakage by 10%.
- 4. The air sealing must be purchased on or after April 1, 2023 and must be installed by March 31, 2024. All 2023 Program rebate applications must be received by April 30, 2024.
- 5. Submit: (1) a completed rebate application form along with (2) a copy of the original invoice/receipt and (3) copy of the door blower report detailing the pre and post duct leakage and percentage of improvement. If rebate is transferred to contractor, both customer and contractor must sign invoice.
- 6. Rebates will be processed and paid on a First In, First Out (FIFO) basis. Rebate will be processed in approximately 4 to 6 weeks. Terms and conditions subject to change without notice.
