V. Rebate Terms and Conditions

1. Insulation must be installed by a participating contractor in a residence that receives New Mexico Gas Company residential gas service, as evidenced by the New Mexico Gas Company customer account number.
2. Customer's home **MUST** have a natural gas fueled heat source as its primary source of heating (primary heat sources using propane, solar or electric are ineligible for rebate payment).
3. To qualify for Tier I incentives, the R-value of the existing roof/attic insulation must be R-11 or less and the insulation installed must be R-19 or greater. To qualify for Tier II incentives, the R-value of the existing roof/attic insulation must be between R-12 and R-19 and the insulation installed must increase the R-Value to R-38 or greater. To qualify for Crawl Space incentives, the R-Value of the existing crawl space insulation must be R-0 and the insulation installed must be R-19 or greater.
4. The insulation must be purchased on or after April 1, 2025 and must be installed by March 31, 2026. All 2025 Program rebate applications must be received by April 30, 2026.
5. Submit: (1) a completed rebate application form along with (2) a copy of the original invoice/receipt and (3) photo documentation of pre-existing R-value taken next to a ruler. Invoice/receipt must include the R- Value of the pre-existing insulation, R-Value of the insulation installed and heated square footage covered. If rebate is transferred to contractor, both customer and contractor must sign invoice.
6. Flat roofed homes: Insulation added to the roof deck will qualify for incentives when the attic space is converted into an unvented conditioned space. Insulation in the existing attic must meet the program requirements. If contractor converts existing attic space into an unvented conditioned space, description of work must be stated on invoice.
7. Rebates will be processed and paid on a First In, First Out (FIFO) basis. Rebate will be processed in approximately 4 to 6 weeks. Terms and conditions subject to change without notice.
